Ali launched IOFA in 1999, after returning from three years abroad as a Peace Corps Volunteer and Fulbright scholar where she became aware of the extensive trafficking of children and youth. Ali brings more than 20 years experience in organizational development, program design, grant writing, building strategic partnerships, designing and facilitating strategic planning initiatives, conducting research and evaluation, and writing curricula. Her work has focused on improving the health and well-being of vulnerable adolescents in more than 12 countries especially those who are parentless, unaccompanied, LGBTQ, juvenile justice involved or commercially sexually exploited. Ali is an internationally recognized expert on the issues of child and adolescent trafficking and exploitation, and as a pioneer in this field, she has created several model programs and founded numerous organizations, networks, and coalitions to coordinate the multi-disciplinary work required to assist trafficked persons. Ali is known for her strategic responses to emerging problems and issues and her ability to bring groups together for a comprehensive response. **Cindy C. Liou, Esq.** is an attorney and consultant and is participating in the National Human Trafficking and Disabilities Working Group in her individual capacity through Cindy C. Liou Consulting and Law. She is also currently the Deputy Director of Legal Services at Kids in Need of Defense (KIND), a national non-profit working to provide legal counsel to unaccompanied refugee and immigrant children in the United States. Previously, she was the Director of the Human Trafficking Project at Asian Pacific Islander Legal Outreach (API Legal Outreach), where she also co-counseled several civil litigation cases on behalf of human trafficking survivors, and represented survivors of domestic violence, sexual assault, elder abuse, and hate crimes. She continues to provide consulting and training on topics ranging from human trafficking, domestic violence lethality, to best practices on how to collaborate in cross-disciplinary teams to support survivors of violence. She is also formerly the Co-Chair of the Policy Committee of the Freedom Network to Empower Trafficked and Enslaved Persons (USA). Cindy is also the co-author of

several articles and the second edition of the manual Representing Survivors of Human Trafficking. Before working at API Legal Outreach, Cindy handled a variety of pro bono cases at Wilson Sonsini Goodrich & Rosati, ranging from asylum to police misconduct cases. Cindy is a graduate from Stanford Law School and the University of Washington.

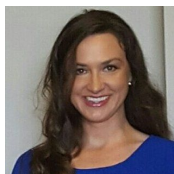
